## **Inspector General Report**

## 1. Compliance

IG Chatelain states the report distribution module, Vault Room, has moved to a new platform. The JPOIG is experiencing changes in service and quality which Vault Room is working on resolving. She reports training has begun on the Engagement Software. IG Chatelain states that 2023 is an election year and Jefferson Parish ordinance restricts the JPOIG from issuing reports 90 days prior to the election date.

IG Chatelain states a new audit report will be presented at the March meeting. Jerry Sullivan, counsel for the Ethics and Compliance Commission, questions IG Chatelain about the recent disclosure of confidential information prior to the release of the final report to the media. Mr.
