## 1. Premium Pay

Inspector General McClintock reports the Jefferson Parish Personnel Board proposed the rules governing premium pay be amended as recommended by the Premium Pay Audit issued by the JPOIG. The change in personnel rules is pending Council approval. The IG fields questions from Jerry Sullivan and the Commissioners.

Paul Lumpkin reports interest accrued on all Council District BP accounts totals 964,820.00. The remaining balance of all 5 Council Districts is approximately eleven million. The starting balance was twenty five million.
